## RESOLUTION NO. 57-1203 ,\$99

A RESOLUTION URGING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS TO DIRECT HANJIN ITOCHU, INC., THE ACCREDITED CONTRACTOR OF MRT II PROJECT WHICH TRAVERSES THE WHOLE OF AURORA BLVD., FROM KATIPUNAN AVENUE TO ARANETA AVENUE IN QUEZON CITY, TO IMMEDIATELY UNDERTAKE NECESSARY ROAD REPAIRS AND MAINTAIN THE ROAD WORTHINESS OF THE SAID THOROUGHFARE.

WHEREAS, Aurora Blvd. is one of the major thoroughfares in Metro Manila being used by many commuters going to and coming from Marikina, Cainta, Taytay and other neighboring towns and provinces;

WHEREAS, the ongoing construction of the MRT II Project along Aurora Blvd. by Hanjin Itochu, Inc., has taken its toll on the road and has left many portions of the road in deteriorated condition;

WHEREAS, the project as expected would still take years to be finished, hence, it is imperative that the accredited contractor undertakes the necessary road repair and maintenance for and in the interest of the residents of the surrounding community and the riding public in general;

WHEREAS, seemingly, the accredited contractor, Hanjin Itochu, Inc., with the frequent use of the road by their heavy equipment which ultimately destroyed portions of Aurora Boulevard does not give any attention to the effect of their construction activity and does not respond immediately to the situation;
