RESOLUTION NO. SP. 1204 , S-99

A RESOLUTION STRONGLY URGING HIS HONOR, MAYOR ISMAEL A. MATHAY, JR., TO GRANT FINANCIAL ASSISTANCE TO MR. PATRICIO L. DUMLAO, WHO RETIRED AS CITY GOVERNMENT OFFICE HEAD III, BUSINESS PERMITS AND LICENSING OFFICE, QUEZON CITY, IN THE AMOUNT OF TWO HUNDRED THOUSAND (P200,000.00) PESOS TO BE TAKEN FROM THE 1999 BUDGET OF THE OFFICE OF THE CITY MAYOR UNDER ITEM GRANTS, AIDS AND CONTRIBUTIONS.

WHEREAS, Mr. Patricio L. Dumlao has been in the public service for more than thirty (30) years serving the people and legitimate businessmen who are conducting business within the territorial jurisdiction of Quezon City with utmost dedication through the issuance of business permits and licenses;

WHEREAS, during his stint as Chief of the Business Permits and Licensing Office, he introduced several innovations, ways and means to improve the collection of business taxes and effective issuance of business permits and licenses to the working class and the owners/operators of small and medium scale industries, thus, earning for him respect and courtesy among his peers and co-departments heads;

WHEREAS, such exhaustive and long years of public service should be given due recognition by the local government unit of Quezon City;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, His Honor, Mayor Ismael A. Mathay, Jr., to grant financial assistance to Mr. Patricio L. Dumlao, who retired as City Government Office Head III, Business Permits and Licensing Office, Quezon City, in the amount of Two Hundred Thousand Pesos (P200,000.00) to be taken from the 1999 Budget of the Office of the City Mayor under item grants, aids and contributions.
