RESOLUTION NO. ~~SP-1209~~ S-99

A RESOLUTION STRONGLY URGING PRESIDENT JOSEPH EJERCITO ESTRADA TO APPOINT WOMEN SENIOR EXECUTIVES WHO ARE QUALIFIED TO HIGHER AND MANAGERIAL GOVERNMENT POSITIONS IN THE NATIONAL GOVERNMENT IN RECOGNITION OF THE WOMEN'S GREATEST ROLE AND VALUABLE CONTRIBUTION IN NATION BUILDING.

Introduced by Councilor WILMA AMORANTO-SARINO.

WHEREAS, the Selection Committee in selecting possible candidates to higher and vital positions in the national government is permissive, thus, giving much regard and attention to men leaving behind the idea of entertaining and including in the list of candidates/nominees, women senior executives who are qualified and/or in spite of their possessed qualification and expertise;

WHEREAS, women are a dominant force in small and medium scale industries and thus, represents the 85% of the work force, indicating women's deep concern in our economy and apparent effectivity and efficiency in business management;

WHEREAS, Women's Senior Executives also occupy positions in some country's top corporations, as noted by no less than the Department of Trade and Industry (DTI) through the formation of Women's Business Council Philippines (WBCP) in 1997 in recognition of the role and contribution of women in business and to the economy;

WHEREAS, Section 16, Article II of the 1987 Constitution explicitly provides that:

"The state recognizes the role of women in nation building and shall ensure the fundamental equality before the law of women and men;"

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby strongly urge, President Joseph Ejercito Estrada to appoint Women Senior Executives who are qualified to higher and managerial government positions in the national government in recognition of the women's greatest role and valuable contribution in nation building.




