RESOLUTION NO. SP. 1218 3, S-99

A RESOLUTION REQUESTING HIS EXCELLENCY, PRESIDENT JOSEPH EJERCITO ESTRADA, TO RECOMMEND A NON-GOVERNMENT ORGANIZATION TO SIT AS MEMBER IN IMPLEMENTING THE APPROVED DEVELOPMENT PLAN AND PROGRAM OF PAYATAS 2000, PURSUANT TO EXECUTIVE ORDER NO. 28 AND AN UNNUMBERED ADMINISTRATIVE ORDER.

WHEREAS, it is a laudable and positive move on the part of the national leadership to address so many basic services in creating the Payatas 2000 which will involve key departments, offices and local government which will redound to the people's benefit in the coming millenium;
