A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO ATTY. MARCELINO F. BAUTISTA, FORMER REGIONAL TRIAL COURT JUDGE, QUEZON CITY, FOR HIS MORE THAN TWENTY TWO (22) YEARS OF SERVICE, IN THE AMOUNT OF THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00), SUCH AMOUNT TO BE TAKEN FROM THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS OF THE OFFICE OF THE CITY MAYOR UNDER THE CITY'S ANNUAL BUDGET FOR FISCAL YEAR 1999.

WHEREAS, Judge Marcelino F. Bautista, compulsory retired from the service having reached the age of sixty-five (65) on July 17, 1998;

WHEREAS, Judge Bautista has rendered a total of twenty-two (22) years of continuous, dedicated, efficient and competent service, the last eleven (11) years of which was being a member of the judiciary assigned in Quezon City;

WHEREAS, prior to his appointment as Judge in Quezon City, he was a prosecutor under the Department of Justice for seven (7) years and four (4) years as a Legal Counsel of the Ministry of Human Settlement;


WHEREAS, it is but fitting and proper that financial assistance be granted to Judge Marcelino F. Bautista in recognition of his outstanding and unblemished record for his many years of continuous, faithful and devoted service to the Quezon City government as a member of the Judiciary.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to Atty. Marcelino F. Bautista, former Regional Trial Court Judge, Quezon City, for his more than twenty two (22) years of service, in the amount of Three Hundred Fifty Thousand Pesos (P350,000.00), such amount to be taken from the appropriations for grants, subsidies and contributions of the office of the City Mayor under the City's Annual Budget for Fiscal Year 1999.
