RESOLUTION NO. 87-122 5 , S 99

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE KAGAWAD MANUEL A. GONZALO OF BARANGAY NORTH FAIRVIEW, QUEZON CITY, WHO DIED ON OCTOBER 21, 1998, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00), CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS IN THE CITY TREASURY.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the bereaved family of the late Kagawad Manuel A. Gonzalo of Barangay North Fairview, Quezon City, who died on October 21, 1998, in the amount of Thirty Thousand Pesos (P30,000.00), chargeable against the appropriations for grants, subsidies and contributions in the Annual Budget of the Office of the City Mayor or from any available funds in the City Treasury.
