RESOLUTION NO. SP-1226 3-99

A RESOLUTION GRANTING FINANCIAL ASSISTANCE TO THE BEREAVED FAMILY OF THE LATE KAGAWAD PEDRO BIGLANG-AWA OF BARANGAY BAGBAG, QUEZON CITY, WHO DIED ON NOVEMBER 19, 1998, IN THE AMOUNT OF THIRTY THOUSAND PESOS (P30,000.00) CHARGEABLE AGAINST THE APPROPRIATIONS FOR GRANTS, SUBSIDIES AND CONTRIBUTIONS IN THE 1999 ANNUAL BUDGET OF THE OFFICE OF THE CITY MAYOR OR FROM ANY AVAILABLE FUNDS OF THE CITY TREASURY.

WHEREAS, his dedicated and valuable services redounded not only to the benefit of the said barangay but also to the people of Quezon City;

WHEREAS, it is fitting that the services rendered by Kagawad Pedro Biglangawa be recognized and acknowledged by way of granting financial assistance to his family in the amount of Thirty Thousand Pesos (P30,000.00);

NOW, THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, financial assistance to the bereaved family of the late Kagawad Pedro Biglang-awa of Barangay Bagbag, Quezon City, who died on November 19, 1998, in the amount of Thirty Thousand Pesos (P30,000.00) chargeable against the appropriations for grants, subsidies and contributions in the 1999 Annual Budget of the Office of the City Mayor or from any available funds of the City Treasury.
