RESOLUTION NO. SP-1239 3-99

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO TOTAL PETROLEUM PHILIPPINES CORPORATION FOR THE CONSTRUCTION OF TWO (2) GASOLINE SERVICE STATIONS AT VARIOUS LOCATIONS IN QUEZON CITY.

WHEREAS, petitioner, Total Petroleum Philippines Corporation, has requested the Quezon City Council thru the Office of the Majority Floor Leader for the issuance of a Special Use Permit for the construction of two (2) gasoline service stations at various locations in Quezon City;

WHEREAS, the construction and establishment of the two (2) gasoline service stations in the place hereinbelow mentioned are beneficial to the general public and that the areas identified or the proposed sites conform with the list of permitted uses which require the issuance of a Special Use Permit as provided under Ordinance No. SP-22, S-92, otherwise known as "The Quezon City Zoning Ordinance of 1992" and its Implementing Rules and Regulations (IRR) through appropriate measure passed by the City Council authorizing the construction thereof, to wit:
