A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE HONORABLE CITY MAYOR, ISMAEL A. SANTOS, AS THE SECOND PARTY, FOR THE INSTALLATION OF PARK LAMP POST ALONG K-1 STREET, BARANGAY WEST KAMIAS, QUEZON CITY, IN THE AMOUNT OF ONE HUNDRED THIRTY-EIGHT THOUSAND PESOS (P138,000.00) TO BE CHARGED AGAINST THE LINGAP FUNDS OF THE 1998 CITY BUDGET.


NOW, THEREFORE,
