A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY THE HONORABLE CITY MAYOR, ISMAEL A. MATHAY, JR., AS THE FIRST PARTY AND GELIAN TRADING AND CONSTRUCTION, REPRESENTED BY ITS MANAGER, ELOISA A. SANTOS, AS THE SECOND PARTY, FOR THE REHABILITATION OF BROOKSIDE PATHWALK, PANSOL KAINGIN 2, BALARA, QUEZON CITY IN THE AMOUNT OF SEVENTY-EIGHT THOUSAND PESOS (P78,000.00) TO BE CHARGED AGAINST THE LINGAP FUNDS OF THE 1998 CITY BUDGET.
