A RESOLUTION CONFIRMING THE DONATION BY THE CITY MAYOR, HON. ISMAEL A. MATHAY, JR., OF TWO (2) AIRCONDITIONING UNITS TO THE NATIONAL HISTORICAL INSTITUTE FOR THE USE OF THE QUEZON MEMORIAL SHRINE AND MUSEUM.

WHEREAS, the National Historical Institute has sought the help of the Quezon City government for the acquisition of two (2) air-conditioning units for the use of the Quezon Memorial Shrine and Museum;

WHEREAS, the Quezon City government, under the able leadership of the Honorable Ismael A. Mathay, Jr., has donated to the National Historical Institute two (2) air conditioning units, gratis et pro bono;

WHEREAS, such donation was timely for the 118<sup>th</sup> birth anniversary of the late President Manuel L. Quezon, founder of Quezon City;

WHEREAS, under the Deed of Donation, it stipulated that said air-conditioning units shall be for the use of the Quezon Memorial Shrine and Museum;

WHEREAS, under existing laws, the Honorable City Mayor, Ismael A. Mathay, Jr., can only transact business and/or give donations upon authorization or duly prior authorization of the City Council.




NOW, THEREFORE,
