A RESOLUTION RATIFYING THE CONTRACT DATED JULY 27, 1998 ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AS THE FIRST PARTY AND ANGELOT CONSTRUCTION AND GENERAL MERCHANDISE, REPRESENTED BY ITS MANAGER, ANGELITA K. BARRIENTOS, AS THE SECOND PARTY, FOR THE PROPOSED REPAIR AND IMPROVEMENT OF NOVALICHES DISTRICT CENTER (MINI CITY HALL), QUEZON CITY IN THE AMOUNT OF FOUR HUNDRED NINETY-SEVEN THOUSAND TWO HUNDRED FORTY-THREE PESOS AND SIXTY-EIGHT CENTAVOS (P497,243.68).
