A RESOLUTION RATIFYING THE THREE (3) CONTRACTS MADE AND ENTERED INTO BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AS THE FIRST PARTY AND GREENWELLS TRADING AND INDUSTRIES COMPANY, REPRESENTED BY MS. EMILY B. SORIANO, AS THE SECOND PARTY, FOR THE ASPHALTING OF VISAYAS STREET, BARANGAY PAYATAS, QUEZON CITY, IN THE AMOUNT OF ONE HUNDRED THIRTY-THREE THOUSAND AND THIRTY PESOS AND THIRTY TWO CENTAVOS (P133,030.32); MOLAVE EXTENSION I AND II, BARANGAY PAYATAS, QUEZON CITY, IN THE AMOUNT OF TWO HUNDRED FORTY-ONE THOUSAND SEVEN HUNDRED FORTY-FIVE PESOS AND FORTY-TWO CENTAVOS (P241,745.42); FOR THE CONCRETING OF PATHWALK AT SITIO LIBIS, BARANGAY KRUS NA LIGAS, QUEZON CITY, IN THE AMOUNT OF SEVENTY THOUSAND TWO HUNDRED FIFTEEN PESOS AND TWENTY CENTAVOS (P70,215.20).



WHEREAS, the above-stated Contracts are valid and legal in all respects and may be ratified by the City Council.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the three (3) contracts made and entered into by the Quezon City government represented by Mayor Ismael A. Mathay, Jr., as the first party and Greenwells Trading and Industries Company represented by Ms. Emily B. Soriano as the second party, for the asphaltting of Visayas Street, Barangay Payatas, Quezon City, in the amount of One Hundred Thirty-Three Thousand and Thirty Pesos and Thirty-Two Centavos (P133,030.32); Molave Extension I and II, Barangay Payatas, Quezon City, in the amount of Two Hundred Forty-One Thousand Seven Hundred Forty-Five Pesos and Forty-Two Centavos (P241,745.42); for the concreting of pathwalk at Sitio Libis, Barangay Krus na Ligas, Quezon City, in the amount of Seventy Thousand Two Hundred Fifteen Pesos and Twenty Centavos (P70,215.20).
