A RESOLUTION RATIFYING THE THREE (3) CONTRACTS MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY THE HONORABLE MAYOR ISMAEL A. MATHAY, JR., AS THE FIRST PARTY AND ISH CONSTRUCTION, REPRESENTED BY IMELBERTO S. HOLLERO, AS THE SECOND PARTY, FOR THE ASPHALT OVERLAY IN BARANGAY KALIGAYAHAN AND FOR THE INSTALLATION OF STREET LIGHTING FACILITIES IN BARANGAYS STO. DOMINGO, IMMACULATE CONCEPTION, KAUNLARAN, SANTOL AND ROXAS, ALL OF QUEZON CITY, IN THE AGGREGATE AMOUNT OF TWO MILLION FIVE HUNDRED THIRTY-TWO THOUSAND NINE HUNDRED SIX PESOS & ONE CENTAVO (P2,532,906.01)

Mathay, Jr., as the First Party and ISH Construction, represented by Imelberto S. Hollero, as the Second Party, for the asphalt overlay in Barangay Kaligayahan and for the installation of street lighting facilities in Barangays Sto. Domingo, Immaculate Conception, Kaunlaran, Santol and Roxas, all of Quezon City, in the aggregate amount of Two Million Five Hundred Thirty-Two Thousand Nine Hundred Six Pesos & One Centavo (P2,532,906.01).
