# RESOLUTION NO. 8P- 12 71 38-99

A RESOLUTION RATIFYING THE TWO (2) CONTRACTS (ANNEXES "1" & **OUEZON** "2") ENTERED INTO BY AND BETWEEN THE GOVERNMENT REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AS TRADING REN REN CONSTRUCTION & FIRST PARTY AND REPRESENTED BY ITS GENERAL MANAGER ALFONSO KABIGTING, AS THE SECOND PARTY FOR THE IMPROVEMENT OF PAQUITA STREET BGY. GULOD, QUEZON CITY, IN THE AMOUNT OF NINE HUNDRED SEVENTY-NINE THOUSAND ONE HUNDRED FORTY-EIGHT PESOS & CENTAVOS (979,148.40) AND SEVEN HUNDRED THOUSAND ONE HUNDRED THIRTY FOUR PESOS & TWENTY-FIVE CENTAVOS (P760,134.25), RESPECTIVELY.

WHEREAS, after proper negotiations, the City government, represented by Mayor Ismael A. Mathay, Jr., as the First Party entered into a contract with Ren Ren Construction & Trading, represented by its Gen. Manager, Alfonso Kabigting, as the Second Party on June 09, 1997 for the improvement of Paquita St., Bgy. Gulod, Quezon City in the amount of Nine Hundred Seventy-Nine Thousand One Hundred Forty-Eight Pesos & Forty Centavos (P979,148.40), a copy of which is hereto attached as Annex "1" to form an integral part hereof;

WHEREAS, subsequent to the above-stated contract the First Party and the Second Party mutually agreed for additional works on the said improvement of Paquita Street and entered into another contract therefor on October 1, 1997 in the amount of Seven Hundred Sixty Thousand One Hundred Thirty Four Pesos & Twenty-Five Centavos (760,134.25), copy of which is hereto attached as Annex "2" to form an integral part hereof;

WHEREAS, both contracts, Annexes "1" and "2", are valid and legal in all respects and may be ratified by the Quezon City Council.
