A RESOLUTION URGENTLY REQUESTING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO SEGREGATE AND AWARD TO BONAFIDE OWNERS AND RENTERS OF THE ONE THOUSAND (1,000) SQUARE METERS PARCEL OF LAND COVERED AND EMBRACED BY TRANSFER CERTIFICATE OF TITLE NO. 13037 LOCATED IN THE SOUTH EASTERN PORTION OF THE QUEZON CITY GENERAL HOSPITAL COMPOUND, SITIO GAYA-GAYA, BGY. BAHAY TORO, QUEZON CITY, AFTER PAYMENT OF REASONABLE PRICE TO THE QUEZON CITY GOVERNMENT.

WHEREAS, a written request signed by Mr. Roque Nerio, Acting President and Chairman of the Board, respectively, of the Samahang Action ng Sitio Gaya-Gaya, was transmitted to the office of Councilors Antonio L. Sioson and Eufemio C. Lagumbay appealing for the possible award of the area they are presently occupying;

WHEREAS, the owners and renters of the said area have been residing thereat for almost twenty-seven (27) years;

WHEREAS, the subject site consisting of One Thousand (1,000) square meters is a portion of Lot 291, covered by Transfer Certificate of Title Numbered 13037 with a total area of Thirty One Thousand Four Hundred Fifty-Two (31,452) square meters under the name of the Quezon City government;


WHEREAS, the beneficiaries are willing to pay at reasonable price the lots that may be awarded to them;

WHEREAS, it is the thrust of the government to provide shelter/home for the homeless and this is an opportunity to shown them the city's concern;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to request, as it does hereby urgently request, the Honorable Ismael A. Mathay, Jr., City Mayor, Quezon City, to segregate and award to bonafide owners and renters of the One Thousand (1,000) square meters parcel of land covered and embraced by Transfer Certificate of Title Numbered 13037 located in the Southeastern portion of the Quezon City General Hospital Compound, Sitio Gaya-gaya, Bgy. Bahay Toro, Quezon City, after payment of reasonable price to the Quezon City government.
