RESOLUTION NO. SP-1277, S-99

A RESOLUTION ALLOCATING THE AMOUNT OF ONE HUNDRED TWELVE THOUSAND PESOS (P112,000.00) OR SO MUCH THEREOF AS MAY BE NECESSARY FOR THE FINANCIAL ASSISTANCE TO THE VICTIMS OF FIRE AFFECTING SEVENTY THREE (73) FAMILIES AT MANGA STREET, BARANGAY KATIPUNAN, DISTRICT I, QUEZON CITY, ON SEPTEMBER 28, 1999, TO BE TAKEN FROM THE CALAMITY FUND OF THE OFFICE OF THE CITY MAYOR.

WHEREAS, a fire occurred at Manga Street, Barangay Katipunan, District I, Quezon City, on September 28, 1999, that affected seventy-three (73) families as per report submitted by the Social Services Development Department;

WHEREAS, because of this unfortunate incident, our constituents would need the help and assistance of the City government in the form of financial aid for food, clothing and materials for the construction of their houses;

WHEREAS, it is necessary for the City government to extend help to the aforesaid five victims by providing them financial assistance in the amount of Two Thousand Pesos (P2,000.00) per house-owner and One Thousand Pesos (P1,000.00) per house renter/occupants as follows:

39 house-owner @ P2,000.00 each	-	P 78,000.00
34 house-renter/occupants @1,000 each	-	<u>P 34,000.00</u>
		P112,000.00


WHEREAS, these unfortunate family victims, who are presently found in makeshift houses can only hope and pray for the early release of financial assistance from the City government.
