RESOLUTION NO. SP- 1280, 1999

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO AWARD TO THE QUALIFIED OCCUPANTS OF THE NORTHERN PORTION OF LOT 3 (PCS-13-002481) OF THE FORMER QUEZON CITY GOVERNMENT SOCIALIZED HOUSING PROJECT AT SITIO CHAPEL, SEMINARY ROAD, SAN JOSE VILLAGE, BARANGAY BAHAY TORO, THIS CITY, THE LOT THEY PRESENTLY OCCUPY AND TO ALLOCATE FOR A ROAD RIGHT-OF-WAY IN SAID LOT FOR THE USE OF THE RESIDENTS RESIDING AT THE PROPERTY OF MRS. NATIVIDAD F. REYES COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED RT-103743 (50921) ISSUED BY THE QUEZON CITY REGISTER OF DEEDS, TO SERVE AS INGRESS/EGRESS OF RESIDENTS THEREAT.

WHEREAS, the City government owns a certain government lot at Sitio Chapel Seminary Road, San Jose Village, Barangay Bahay Toro, Quezon City;

WHEREAS, the present occupants of said lot, which is in the northern part of the former socialized housing project as shown in Lot 3 (PCS-13-002481), bonded themselves into an association named Samahan Magkakapitbahay San Jose II, Inc., (SAMABA);

WHEREAS, SAMABA under Resolution No. 001 requested the Barangay Council of Barangay Bahay Toro to petition the City government through the Quezon City Council to award said lot to qualified occupants of the lot owned by the City government which they have occupied for more than fifteen (15) years;

WHEREAS, the said lot also serves as ingress/egress of residents of the property of one Natividad F. Reyes, technically described as Lot 43-B-21, TCT No. RT-103713 (50921);

WHEREAS, the Quezon City government is desirous of helping the residents/ occupants to acquire lot of their own;

Mathay, Jr., City Mayor, Quezon City, to award to the qualified occupants of the northern portion of lot 3 (PCS-13-002481) of the former Quezon City government socialized housing project at Sitio Chapel, Seminary Road, San Jose Village, Barangay Bahay Toro, this City, the lot they presently occupy and to allocate for a road right-of-way in said lot for the use of the residents residing at the property of Mrs. Natividad F. Reyes covered by Transfer Certificate of Title Numbered as RT-103743 (50921) issued by the Quezon City Register of Deeds, to serve as ingress/egress of residents thereat.
