RESOLUTION NO. SP-1281 S-99

A RESOLUTION GRANTING INCENTIVE AWARDS TO WINNERS OF THE CLEANLINESS PROGRAM AND OPLAN ESTERO IN EVERY BARANGAY OF QUEZON CITY.

WHEREAS, the Quezon City government, aware of the need for continuous general cleanliness program and in consonance with Oplan Estero to clean the waterways in every barangay of Quezon City, has adopted a year-round cleanliness and beautification drive at the barangay level;

WHEREAS, in order to effectively implement the program, the invaluable support of the barangays of the City is called upon in the implementation of this drive;

WHEREAS, to encourage total and sincere participation by the barangays towards the attainment of program's goals, incentive awards in the form of plaques/trophies will be awarded to the top three barangays of each district. Awarding shall be held during the last month of each semester specifically on June 25 and October 12 to ensure continuous support to the program. A system of rating, shall be adopted for the purpose of monitoring the said program, as well as the basis of awarding;

WHEREAS, a committee composed of key representatives from Task Force Clean and Green, City Engineer's Office, Cultural and Tourism Affairs Office, City Administrator's Office and Liga ng mga Barangay, Quezon City Chapter, shall be created to effect proper evaluation of candidates and the establishment of the rating system needed thereat;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, the incentive awards to winners of the Cleanliness Program and Oplan Estero in every barangay of Quezon City.

RESOLVED, FURTHER, that the amount of One Hundred Fifty Thousand Pesos (P150,000.00) for the purchase of trophies/plaques and the awarding ceremonies be appropriated annually to be taken from the Special Activity Fund of the City Mayor.

RESOLVED, FURTHERMORE, that a copy of this resolution be forwarded to His Honor, Mayor Ismael A. Mathay, Jr., for his comment and approval regarding the general implementation of the said program.

RESOLVED, FINALLY, that copies of this resolution be furnished to all Department Heads and Chiefs of Offices concerned and Barangay officials of Quezon City for their information and guidance.
