A RESOLUTION GRANTING MEDICAL ASSISTANCE IN THE AMOUNT OF TEN THOUSAND PESOS (P10,000.00) FROM ANY AVAILABLE FUNDS OF THE CITY GOVERNMENT TO SANGGUNIANG KABATAAN (SK) KAGAWAD MARIAN E. BARBON OF BARANGAY KRISTONG HARI, DISTRICT IV, THIS CITY, WHO HAS UNDERGONE MEDICAL OPERATION AND TREATMENT DUE TO HEART ENLARGEMENT.

WHEREAS, the granting of medical assistance to the SK Kagawad Marian E. Barbon is an act of humane consolation for her public service as SK Kagawad of Bgy. Kristong Hari since May 1996;

WHEREAS, it is only proper and right that the officers of the Sangguniang Kabataan Council composed of SK Chairman, seven (7) SK Kagawads, a Treasurer and a Secretary, be entitled to medical assistance and care because of the nature of their duties and responsibilities as public servants of their respective barangays;

WHEREAS, Section 458 of the Local Government Code of 1991 provides that the Sangguniang Panlungsod shall approve ordinances/resolutions that provide for the care of the sick and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age;

WHEREAS, the humble gesture of giving medical assistance to SKs reflects the City government's obligation and commitment to ensure and uplift the general welfare of the youth of this city;


