RESOLUTION NO. SP- 1285, S-99

A RESOLUTION REQUESTING/URGING THE HONORABLE CITY MAYOR ISMAEL A. MATHAY, JR., TO SEGREGATE AND AWARD TO THE ACTUAL OCCUPANTS ON THE FIVE THOUSAND (5,000) SQUARE METER PARCEL OF LAND OR LOT R.P. 3-B-2-A-2, PSD-10356 (PRE-WAR NUMBER BEING LOT 2, PSD-7365) CONSISTING OF TWENTY THOUSAND THREE HUNDRED EIGHT (20,308) SQUARE METERS COVERED BY TRANSFER CERTIFICATE OF TITLE NUMBERED 35979 FORMERLY OWNED BY THE PHHC LOCATED AT BARANGAY KATIPUNAN, QUEZON CITY.

WHEREAS, the property consisting of Twenty Thousand Three Hundred Eight (20,308) square meters covered by Transfer Certificate of Title Numbered 35979 of the Registry of Deeds of Quezon City was donated by the PHHC to the Quezon City government;

WHEREAS, five thousand (5,000) square meters of the property was reserved for a slaughterhouse;

WHEREAS, the slaughterhouse project had been abandoned and instead had been occupied by our homeless Citymates who have formed themselves into an organization called TANGLAW NG MAHIHIRAP SA LUNGSOD QUEZON, INC.;

WHEREAS, the list of the names and signatures of the members of the TANGLAW NG MGA MAHIHIRAP SA LUNGSOD QUEZON, INC., who are presently occupying the said lot since 1987 is hereto attached;


