A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO INFOCOM COMMUNICATIONS NETWORK INC., FOR THE CONSTRUCTION/ERECTION OF A TELECOMMUNICATION TOWER AT PERCON PLAZA BUILDING, QUIRINO HIGHWAY, BARANGAY LAGRO, QUEZON CITY.

WHEREAS, petitioner Infocom Communications Network, Inc., is an operator of a telecommunication services network;

WHEREAS, petitioner Infocom Communications Network, Inc., is embarking on an expansion program of its telecommunication network facilities in Quezon City and has identified an area wherein its telecommunication tower will be located;

WHEREAS, the petitioner has applied with the Quezon City Council for the issuance of a Special Use Permit as required by Ordinance No. SP-22, S-92, otherwise known as "The Quezon City Zoning Ordinance of 1992" and its implementing rules and regulations;

WHEREAS, it is to the public interest that the improvement, modernization and expansion of telecommunications facilities, particularly in Quezon City, are encouraged and expedited.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Infocom Communications Network, Inc., for the construction/erection of a Telecommunication Tower at Percon Plaza Building, Quirino Highway, Barangay Lagro, Quezon City.
