## RESOLUTION NO. SP- 1293, S-99

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO EASYCALL COMMUNICATIONS PHIL., INC. FOR THE CONSTRUCTION OF ITS NEW MAYA RADIO BASE STATION AT L-3 BLK 32, EDSA, BARANGAY E. RODRIQUEZ, CUBAO, QUEZON CITY.

WHEREAS, petitioner Easycall Communications Phils., Inc. is embarking on an expansion program of its radio telecommunications facilities in Quezon City and has identified Lot 3 Blk. 32 EDSA, Brgy. E. Rodriquez, Cubao, Quezon City, where its New Maya Radio Base Station will be located/constructed;

WHEREAS, the construction of a radio transmitting station conforms with the list of permitted uses which requires the issuance of a Special Use Permit as provided for under Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992" and its implementing rules and regulations, through an appropriate measure to be passed by the Quezon City Council authorizing the construction thereof;

WHEREAS, petitioner Easycall Communications Phils., Inc. has applied with the Quezon City Council for the issuance of a Special Use Permit for the said construction of its radio base station as required by the above-stated Ordinance;

WHEREAS, it is to the public interest, convenience and benefit that the improvement, modernization and expansion of radio telecommunications facilities particularly in Quezon City are encourage and expedited.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to petitioner Easycall Communication Phils., Inc., for the construction of its New Maya Radio Base Station at Lot 3, Blk 32 EDSA, Brgy. E. Rodriguez, Cubao, Quezon City; PROVIDED, HOWEVER, that Easycall Communication Phils., Inc. shall bear the exclusive responsibility for the sound maintenance of the above-stated radio station/facilities; PROVIDED, FURTHER, that Easycall Communications Phils, Inc. shall guarantee that no interference with or damage to local electrical appliances or other properties will likely result therefrom;
