RESOLUTION NO. SB^N 1302, S-99

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO SEA OIL PETROLEUM CORPORATION FOR THE CONSTRUCTION OF THREE (3) GASOLINE STATIONS AT RETIRO STREET CORNER LABO STREET, LA LOMA, MINDANAO AVENUE AND P. TUAZON STREET, ALL IN QUEZON CITY.

WHEREAS, petitioner Seaoil Petroleum Corporation has requested the Quezon City Council for the issuance of a Special Use Permit for the construction of three (3) gasoline service stations, at Retiro Street corner Labo Street, La Loma, Mindanao Avenue, and P. Tuazon Street, all in Quezon City;

WHEREAS, the construction and establishment of the gasoline service stations in the above-stated areas, are beneficial to the general public and that the proposed sites conform with the list of permitted uses which require the issuance of a Special Use Permit as provided under Ordinance No. SP-22, S-92, otherwise known as the "Quezon City Zoning Ordinance of 1992", and its Implementing Rules and Regulations through an appropriate measure passed by the City Council authorizing the construction thereof.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the issuance of a Special Use Permit to Seaoil Petroleum Corporation for the construction of three (3) Gasoline Service Stations at Retiro Street corner Labo Street, La Loma, Mindanao Avenue, and P. Tuazon Street, all in Quezon City.
