A RESOLUTION EXPRESSING THE CITY COUNCIL'S PROFOUND FELICITATIONS AND CONGRATULATIONS TO QUEZON CITY CIVIL REGISTRAR RAMON MANANZAN MATABANG FOR HIS RECENT ELECTION AS PRESIDENT OF THE PHILIPPINE ASSOCIATION OF CIVIL REGISTRARS DURING ITS FIFTH NATIONAL CONVENTION HELD IN BAGUIO CITY ON 15 TO 18 JUNE 1999.

WHEREAS, prior to his stint as a government functionary, City Civil Registrar Ramon M. Matabang has gained wide and varied experiences in various capacities, as Auditor, Director, Executive Vice-President and eventually President of the PCI Bank Employees Union; his leadership in unionism spanned a total of twelve (12) years from 1976 to 1988;

WHEREAS, City Civil Registrar Ramon G. Matabang has actively participated in and attended international symposia and fora on industrial relations, management systems, grievance management, arbitration and conciliation held in various venues, such as, the Republic of Korea, Singapore and Malaysia;

WHEREAS, an illustrious son of Bayambang, Pangasinan, City Civil Registrar Ramon M. Matabang began his career in the government service as Consultant of the Industrial Relations Office from April, 1986 to September, 1987 and later moved on to become an Assistant Chief Executive Staff of the Office of the City Mayor from 02 February to 31 August 1988;

WHEREAS, Mr. Ramon M. Matabang was appointed City Civil Registrar on September 1, 1988; and has since then occupied such position as a testament to the efficiency and reforms he has instituted in the field of census-taking, statistics and management;

WHEREAS, aside from his public duties, City Civil Registrar Ramon G. Matabang is also active in professional organizations, occupying positions of responsibility such as President of Rotary Club of Cubao North (District 3780); President Metro Manila Civil Registries Association, Inc., Adviser, young Professional of the Philippines, Inc.; President PCI Bank Employees Consumers Cooperative, Inc.; Chairman, Quezon City Hall Employees Athletic Association; Vice President, RCCN Golden Heart Foundation, Inc., and other socio-civic activities;

WHEREAS, owing to his sterling performance and outstanding leadership, City Civil Registrar Ramon M. Matabang was among the nominees to receive the prestigious Ten Outstanding Young Men Award (TOYM) in the field of public service and went on to receive the Salamin ng Bayan Award for public servants in the government agencies given by the Catholic Bishop Businessmen's Conference

(CBCP), the Civil Service Commission (CSC) and the Office of the President, Employer of the Year Award (1985) given by the Personnel Management Association of the Philippines, in recognition of his achievements in the promotion of harmonious relationship and industrial peace between the PCI Bank and the Union all these feat were achieved in the year 1991;

WHEREAS, during the annual convention of the Philippine Association of Civil Registrar (PACR), City Civil Registrar Ramon G. Matabang was unanimously nominated and elected as president of the PACR in order to carry on the massive reforms it has started and to sustain its drive urging the Congress of the Philippines to enact House Bill No. 514 which empowers local civil registrars to correct common typographical or clerical errors in birth, marriage or death certificates - all with the end in view of facilitating census-taking, information management and to assist in the clearing of court dockets as a result of numerous petitions under the rules of special procedures;


WHEREAS, the election of the City Civil Registrar Ramon G. Matabang as President of the PACR is not only a testament to his personal leadership qualities and skills, rather, it is a reaffirmation that indeed Quezon City is a well-spring and powerhouse source of nationally qualified leaders and managers.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to express, as it does hereby express, the City Council's profound felicitations and congratulations to Quezon City Civil Registrar Ramon Mananzan Matabang for his recent election as President of the Philippine Association of Civil Registrars during its Fifth National Convention held in Baguio City on 15 to 18 June 1999.
