RESOLUTION NO. SP- 1315 , S-99

A RESOLUTION AUTHORIZING HIS HONOR, ISMAEL A. MATHAY, JR., CITY MAYOR, QUEZON CITY, TO NEGOTIATE FOR THE ACQUISITION OF VARIOUS PARCELS OF LAND WITH AN AGGREGATE AREA OF ELEVEN THOUSAND FIVE HUNDRED SEVENTY-SEVEN (11,577) SQUARE METERS COVERED BY TRANSFER CERTIFICATES OF TITLE NUMBERED RT-91390, RT-91400 (188226), RT-91398, N-133950 AND RT-79461 (96330) ISSUED BY THE REGISTRY OF DEEDS OF QUEZON CITY, REGISTERED IN THE NAMES OF SUSAN VICENTE, DOROTEO VICENTE, ROMMEL PAULO AND DAVID YAP, RESPECTIVELY, ALL SITUATED ALONG INTERIOR MASAYA, NENITA INTERIOR, BARANGAY GULOD, NOVALICHES, QUEZON CITY, **EVENTUAL** SALE TO THE PRESENT AND QUALIFIED BENEFICIARIES/OCCUPANTS UNDER THE COMMUNITY MORTGAGE PROGRAM (CMP).

WHEREAS, there are five (5) contiguous parcels of land with an aggregate area of Eleven Thousand Five Hundred Seventy-Seven (11,577) square meters which are presently occupied by One Hundred Thirty (130) families who are members of the INTERIOR MASAYA-NENITA INTERIOR UNIFIED NEIGHBORHOOD ASSOCIATION, INC., which are technically described as follows:

all situated along Interior Masaya, Nenita Interior, Barangay Gulod, Novaliches, Quezon City, which have been occupied continuously for the last fifteen (15) years, thereby qualifying them to be the beneficiaries of these parcels of land under the Urban Development and Housing Act (UDHA) or Republic Act 7279;

WHEREAS, the Sangguniang Barangay of Barangay Gulod, Quezon City, has passed Resolution No. 31, S-97, requesting the City Council of Quezon City, thru the Honorable City Mayor, Ismael A. Mathay, Jr., for the expropriation of said parcels of land, to be acquired as a socialized housing project thru the Community Mortgage Program (CMP);

WHEREAS, the officers and members of the association have requested the Quezon City Council to assist them in acquiring the said parcels of land for eventual sale to the qualified beneficiaries under the Community Mortgage Program;

WHEREAS, Section 19 of Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", provides that:

"SEC. 19. Eminent Domain – A local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the powers of eminent domain for public use, or purpose, or welfare for the benefit of the poor and the landless, x x x.";

NOW, THEREFORE.

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, His Honor, Mayor Ismael A. Mathay, Jr., Quezon City, to negotiate for the acquisition of various parcels of land with an aggregate area of Eleven Thousand Five Hundred Seventy-Seven (11,577) square meters covered by Transfer Certificates of Title Numbered RT-91390, RT-91400 (188226), RT-91398, N-133950 and RT-79461 (96330), issued by the Registry of Deeds of Quezon City, registered in the names of Susan Vicente, Doroteo Vicente, Rommel Paulo and David Yap, respectively, all situated along Interior Masaya, Nenita Interior, Barangay Gulod, Novaliches, Quezon City, for eventual sale to the present and qualified beneficiaries/occupants under the Community Mortgage Program (CMP).
