RESOLUTION NO. SP-1316, S-99

A RESOLUTION RATIFYING THE VARIOUS CONTRACTS MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY HIS HONOR, MAYOR ISMAEL A. MATHAY JR., AS FIRST PARTY, AND BENTIDEL ENTERPRISES AND DEVELOPER, REPRESENTED BY BENJAMIN T. DELFIN., AS THE SECOND PARTY, FOR THE WORKS/PROJECTS IMPLEMENTED/UNDERTAKEN BY THE COMMUNITY RELATIONS OFFICE, QUEZON CITY.

- Annex G - Installation of Seven (7) units Artesian Well in Barangay Bagong Silangan;

- Annex I - Installation of One (1) unit Artesian Well in Kalantiyaw Elementary School;
