RESOLUTION NO. SP- 1579, S-99

A RESOLUTION URGING THE CITY MAYOR, HONORABLE MAYOR ISMAEL A. MATHAY, JR., TO CAUSE THE CONSTRUCTION OF AN ADDITIONAL SCHOOL BUILDING IN CAMP GEN. EMILIO AGUINALDO HIGH SCHOOL AND ALLOCATING THE NECESSARY FUNDS THEREFOR, TO BE TAKEN FROM THE SPECIAL EDUCATION FUNDS.

WHEREAS, it is the policy of the state to give priority to education to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, the constitutional mandate to promote education and to make education accessible to all includes the construction of additional school buildings as may be needed by established public schools with a growing population;


WHEREAS, the lack of the necessary school building would be tantamount to a denial of the constitutional mandate to an accessible educational system;

WHEREAS, the establishment of adequate school building within Quezon City would accelerate our drive to inculcate patriotism and nationalism, foster love of humanity, appreciate the role of national heroes in the historical development of the country, teach the rights and duties of citizenship, strengthen ethical and spiritual values, develop moral character and personal discipline, encourage critical and creative thinking broaden scientific and technological knowledge, and promote vocational efficiency;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the City Mayor, Honorable Mayor Ismael A. Mathay, Jr., to cause the construction of an additional school building in Camp. Gen. Aguinaldo High School and allocating the necessary funds therefor to be taken from the Special Education Funds.
