RESOLUTION NO. SP--1 3 2 4 , S-2000

A RESOLUTION RATIFYING THE TWO (2) NEGOTIATED CONTRACTS ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AND ISH CONSTRUCTION, REPRESENTED BY IMELBERTO S. HOLLERO FOR THE PROPOSED RENOVATION OF THE CITY ACCOUNTING OFFICE, THIRD FLOOR, QUEZON CITY HALL, IN THE AMOUNT OF ONE MILLION TWO HUNDRED FORTY-SIX THOUSAND EIGHT HUNDRED SEVENTY-FIVE PESOS AND EIGHT CENTAVOS (P1,246,875.08) (ANNEX "1") AND FOR THE PROPOSED RENOVATION OF THE YAKAP DAYCARE CENTER, MMDA COMPOUND, QUEZON CITY HALL, IN THE AMOUNT OF FOUR HUNDRED THOUSAND TWO HUNDRED NINETY-NINE PESOS AND NINETY CENTAVOS (P400,299.90) (ANNEX "2").

Hollero, for the proposed renovation of the City Accounting Office, 3rd Floor, Quezon City Hall, in the amount of One Million Two Hundred Forty-Six Thousand Eight Hundred Seventy-Five Pesos and Eight Centavos (P1,246,875.08) (Annex "1") and for the proposed renovation of the Yakap Day Care Center, MMDA Compound, Quezon City Hall, in the amount of Four Hundred Thousand Two Hundred Ninety-Nine Pesos and Ninety Centavos (P400,299.90) (Annex "2").
