RESOLUTION NO. SP--1 3 2 5 , S-2000

A RESOLUTION DECLARING THE MONTH OF FEBRUARY AND EVERY YEAR THEREAFTER AS QUEZON CITY'S "NATIONAL CULTURE MONTH" AND CREATING A SPECIAL COMMITTEE TASKED WITH PROVIDING FOR AND IMPLEMENTING A PROGRAM OF ACTIVITIES FOR THE SAID OCCASION.

WHEREAS, the month of February was declared as "National Culture Month" pursuant to Presidential Proclamation No. 683 signed in January 1991 by Her Excellency, the former President Corazon C. Aquino;

WHEREAS, in April, 1992, Republic Act No. 7356 was enacted, creating the National Commission for Culture and the Arts (NCCA) with the mandate to develop, promote and preserve Filipino culture and arts through the formulation of policies in coordination with affiliated private and public agencies;

WHEREAS, this year, the NCCA is supporting an Arts and Culture Festival to be held on February 27, 2000 along Visayas Avenue, Quezon City, dubbed as "Kulturang Kalye: Pista ng Sining at Kulturang Bayan" sponsored by the Unyon ng Manunulat sa Pilipinas in cooperation with Barangay Vasra;

WHEREAS, the aforementined NCAA's initiative in Quezon City should be continued on a yearly basis through a Special Committee composed of the members of the Sangguniang Panlungsod;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to declare, as it does hereby declare, the month of February and every year thereafter as Quezon City's "National Culture Month".
