RESOLUTION NO. SP-1328, S-2000

A RESOLUTION RATIFYING THE CONTRACT (ANNEX "A") MADE AND ENTERED INTO BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR. AND CITY PLANNERS CONSTRUCTION AND TRADING CENTER, REPRESENTED BY MS. EMILY B. SORIANO FOR THE ASPHALTING OF MORNING EXTENSION STREET AT BARANGAY CULIAT, QUEZON CITY, IN THE AMOUNT OF TWO HUNDRED SIXTY-THREE THOUSAND SIX HUNDRED FORTY SEVEN PESOS (P263,647.00.)

WHEREAS, it appearing that the above-stated contract is regular in all aspects, the same may be ratified by the City Council;


NOW, THEREFORE,
