RESOLUTION NO. SP- 1329 - 2000

A RESOLUTION RATIFYING THE CONTRACT (ANNEX "A") MADE AND ENTERED INTO BY THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR. AND GREENWELLS TRADING AND INDUSTRIES COMPANY, REPRESENTED BY MS. EMILY B. SORIANO, FOR THE CONSTRUCTION OF THREE (3) WAITING SHEDS AT BARANGAYS CENTRAL, BAGONG LIPUNAN NG CRAME AND STO NIÑO, QUEZON CITY IN THE AMOUNT OF ONE HUNDRED FORTY-FIVE THOUSAND SIX HUNDRED FORTY-SIX PESOS AND SIXTY-FIVE CENTAVOS.
