RESOLUTION NO. **SP- 1332**, S-2000

A RESOLUTION RATIFYING THE CONTRACT (ANNEX A) MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY HONORABLE HERBERT M. BAUTISTA, AND M.S. GARRIDO CONSTRUCTORS AND DEVELOPERS, REPRESENTED BY MYRNA SANTOS GARRIDO, FOR THE CONSTRUCTION AND INSTALLATION OF A COVERED BASKETBALL COURT WITH STAGE AND BLEACHERS INCLUDING THE FENCING, LIGHTING AND LANDSCAPING OF THE PERIMETER AREA AT BARANGAY BAHAY TORO, QUEZON CITY.

WHEREAS, the Quezon City Council had adopted and passed Resolution No SP-871, S-98, entitled "A Resolution allocating the amount of Three Million Pesos (P3,000,000.00) to defray the cost of the construction and installation of a covered basketball court with stage and bleachers including the fencing, lighting and landscaping of the same to be located at Project 8-B Plaza, bounded by Road 12, Road 19 and Road 11, Barangay Bahay Toro, Quezon City, to be taken from the Legislative Development and Community Assistance Fund of the City Council", is one of the first established public plaza in Quezon City, but has not been properly developed to meet the requirements of the community;

WHEREAS, there is an urgent need to construct and install a covered basketball court which will serve as a multi-purpose hall and gymnasium for the benefit of the residents in the area, especially the youth;

WHEREAS, in order to put the project into full action and implementation, the Quezon City Council has entered into an agreement with a reputable entity, company or corporation which can provide the required expertise;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to ratify, as it does hereby ratify, the Contract (Annex A) made and entered into by and between the Quezon City government, represented by




