RESOLUTION NO. SP- 1337, S-2000

A RESOLUTION URGING THE HONORABLE CITY MAYOR OF QUEZON CITY TO ALLOW THE DISPOSITION OF THE PARCEL OF LAND DESCRIBED IN TRANSFER CERTIFICATE OF TITLE NUMBERED RT-118219 CONSISTING OF TWENTY-SEVEN THOUSAND FIVE HUNDRED FIFTY-ONE (27,551) SQUARE METERS, MORE OR LESS, SITUATED AT TALANAY, BARANGAY BATASAN HILLS, QUEZON CITY, TO BE AWARDED TO THE ACTUAL AND QUALIFIED OCCUPANTS, IN ACCORDANCE WITH AND IN THE MANNER PRESCRIBED BY EXISTING LAWS.

WHEREAS, a parcel of land located at Talanay, Barangay Batasan Hills covered by Transfer Certificate of Title No. RT-118219 consisting of, more or less, Twenty-Seven Thousand Five Hundred Fifty-One (27,551) square meters has been occupied by Quezon City constituents, comprising around six hundred (600) families who have organized themselves into what is known as Samahang Residente ng Talanay, Inc. (SARET, INC.), for twenty-five (25) years;

WHEREAS, the above residents are now petitioning the City government to allow them to acquire the property they are presently occupying, thru direct sale or other legal means;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to urge, as it does hereby urge, the Honorable City Mayor of Quezon City, to allow the disposition of the parcel of land described in Transfer Certificate of Title Numbered RT-118219 consisting of Twenty-Seven Thousand Five Hundred Fifty-One (27,551) square meters, more or less, situated at Talanay, Barangay Batasan Hills, Quezon City, to be awarded to the actual and qualified occupants, in accordance with and in the manner prescribed by existing laws.
