RESOLUTION NO. SP-1345, S-2000

A RESOLUTION GRANTING A SPECIAL PERMIT TO THE GALLERA DE GUISON HERMANOS, INC., (LA LOMA COCKPIT) TO HOLD LOCAL DERBIES AND PINTAKASIS AT THE LA LOMA COCKPIT NUMBERING TWELVE (12) DERBIES AT ONE (1) DERBY PER DAY AND APPROXIMATELY ONE HUNDRED FIFTY SIX (156) LOCAL PINTAKASI(S) FOR THE ENTIRE YEAR 2000, SUBJECT TO THE PROVISIONS OF EXISTING LAWS, ORDINANCES, RULES AND REGULATIONS, AND TO THE PAYMENT OF CORRESPONDING TAXES AND FEES THEREFOR.

WHEREAS, Gallera de Guison Hermanos, Inc., (La Loma Cockpit) which was established in 1902, is known for its fairness in cockfighting ever since it was established;

WHEREAS, the said cockpit had been granted a regular permit to operate since 1996;

WHEREAS, the said cockpit holds eleven (11) derbies per year and pintakasis three (3) days per week, strictly every Thursday, Friday and Saturday;


WHEREAS, the granting of a permit will generate additional income for the City government which could be utilized in the prosecution of its socialized program;

WHEREAS, such grant of a permit will not in a way affect the peace and order situation in the community;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to grant, as it does hereby grant, a special permit to the Gallera De Guison Hermanos, Inc., (La Loma Cockpit) to hold local derbies and pintakasis at the La loma Cockpit numbering twelve (12) derbies at one (1) derby per day and approximately one hundred fifty six (156) local pintakasi(s) for the entire year 2000, subject to the provisions of existing laws, ordinances, rules and regulations, and to the payment of corresponding taxes and fees therefor.
