RESOLUTION NO. SP-1346, S=2000

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE KNIGHTS OF COLUMBUS PADRE GOMEZ ASSEMBLY, FOR THE USE OF A ONE HUNDRED FIFTY (150) SQUARE METER CITY-OWNED PROPERTY AS A NON-GOVERNMENTAL ORGANIZATION'S (NGO) MULTI-PURPOSE SERVICE CENTER.

WHEREAS, Section 34, Chapter 4 of R.A. 7160 provides, as follows:

"Section 34. Roles of People's and Non-governmental Organizations - Local Government Units shall promote the establishment and cooperation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;"


WHEREAS, the Padre Gomez Assembly of the Knights of Columbus, composed of 4th Degree Knights from Quezon City South, has been actively involved for the past years in community upliftment projects particularly through its sponsorship of the yearly Search for "The Outstanding Barangay Councils of South Quezon City, medical outreach missions, sports and youth oriented activities, symposia on good citizenship and youth training, tree planting and community beautification, values oriented activities such as the construction of the Shrine of the Unborn Child, among others;

WHEREAS, the establishment of a non-governmental multi-purpose community service center is aimed at providing assistance, in coordination with the Quezon City government, on youth and sports development, manpower and livelihood training, health care and other related services/activities that will help improve the living conditions of the people and enhance their well-being, especially those who have less in life;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Ismael A. Mathay, Jr., City Mayor, to enter into a Memorandum of Agreement with the Knights of Columbus Padre Gomez Assembly, for the use of a One Hundred Fifty (150) square meter city-owned property as a Non-Governmental Organization's (NGO) Multi-Purpose Service Center.
