## RESOLUTION NO. SP-1348, S-2000

A RESOLUTION AUTHORIZING THE HONORABLE QUEZON CITY MAYOR TO ENTER INTO NEGOTIATED CONTRACT WITH PT ZIEGLER INDONESIA, THRU ITS EXCLUSIVE DISTRIBUTOR AND AGENT, FOR THE SUPPLY AND DELIVERY OF ONE (1) UNIT OF FIRETRUCK TO THE QUEZON CITY GOVERNMENT AT THE PRICE OF TWO HUNDRED TWENTY FIVE THOUSAND DOLLARS (\$225,000.00) INCLUDING COST OF INSURANCE AND FREIGHT CHARGES.

WHEREAS, records show that millions of pesos are lost yearly by the City, in terms of public and private properties to disasters, conflagrations and fire;

WHEREAS, an inventory of existing fire equipment shows that the Bureau of Fire Protection of the Department of Interior and Local Government is insufficient to secure the protection and fire safety of the city government and its residents;

WHEREAS, to obtain the lowest price available, the Quezon City Bids and Awards Committee conducted a canvass of prices of suppliers/dealers or manufacturers who can supply the needed firefighting equipment;

WHEREAS, the Bids and Awards Committee recommended the award to PT Ziegler, through its exclusive Distributor/Agent, the supply and delivery of one (1) unit of firetruck in the amount of Two Hundred Twenty Five Thousand US Dollars (\$225,000.00) with exemption from tax and bank charges under R.A. 7660, and pertinent regulations of the Department of Finance.

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Quezon City Mayor to enter into a negotiated contract with PT Ziegler Indonesia, thru its exclusive Distributor and/or Agent, as recommended by the Bids and Awards Committee, for the supply and delivery of one (1) unit of firetruck to the Quezon City government at the price of Two Hundred Twenty Five Thousand Dollars (\$225,000.00) including cost of insurance and freight charges, subject to such other terms and conditions as may be agreed upon by the parties.
