RESOLUTION NO. SP- 1362, S-2000

A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR. AS THE FIRST PARTY, AND ANGELOT CONSTRUCTION AND GENERAL MERCHANDISE, REPRESENTED BY ITS GENERAL MANAGER, MS. ANGELITA E. BARRIENTOS, AS THE SECOND PARTY, FOR THE IMPROVEMENT OF THE DRAINAGE OF ALLEY 5, SITIO SAN JOSE, BARANGAY BAHAY TORO, QUEZON CITY, IN THE AMOUNT OF ONE HUNDRED FIFTY-FIVE THOUSAND SIX HUNDRED SIXTY-FIVE PESOS (P155,665.00)

Mathay, Jr., executed a Contract with Angelot Construction, and General Merchandise, represented by its General Manager, Ms. Angelita K. Barrientos, as the Second Party, for the improvement of the drainage of Alley 5, Sitio San Jose, Barangay Bahay Toro, Quezon City in the amount of One Hundred Fifty-Five Thousand Six Hundred Sixty-Five Pesos (P155,665.00), as evidenced by a copy of said Contract hereto attached as Annex "1" to form an integral part hereof.
