A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. SANTOS, AS THE SECOND PARTY, FOR THE IMPROVEMENT OF THE MULTIPURPOSE HALL LOCATED AT LITEX ROAD, BARANGAY COMMONWEALTH, QUEZON CITY, IN THE AMOUNT OF THREE HUNDRED EIGHTY-FIVE THOUSAND PESOS (P385,000.00)

NOW, THEREFORE,


