A RESOLUTION ALLOCATING THE NECESSARY AMOUNT TO PROVIDE IMMEDIATE RELIEF ASSISTANCE TO THE SEVENTY-FIVE (75) FAMILIES AFFECTED BY FIRE THAT OCCURRED AT BAI COMPOUND, BARANGAY VASRA, DISTRICT I, QUEZON CITY, THE NECESSARY FUNDS THEREFOR TO BE TAKEN FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.

WHEREAS, a fire occurred at BAI Compound, Barangay Vasra, District I, Quezon City, at around 7:00 p.m., last December 11, 1999, affecting seventy five (75) families;

WHEREAS, these unfortunate fire victims need the help and assistance of the City government in the form of material assistance, such as building materials for the reconstruction of their houses, purchase of food, clothing, etc., in the amount of Two Thousand Pesos (P2,000.00) for each house-owner and One Thousand Pesos (P1,000.00) for each house-renter/sharer;

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to allocate, as it does hereby allocate, the necessary amount to provide immediate relief assistance to the seventy five (75) families affected by fire that occurred at BAI Compound, Barangay Vasra, District I, Quezon City, the necessary funds therefor to be taken from Grants, Subsidies and Contributions or from any other available funds in the City Treasury.
