A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AS THE FIRST PARTY, AND ANGELOT CONSTRUCTION AND GENERAL MERCHANDISE REPRESENTED BY ITS GENERAL MANAGER, MS. ANGELITA K. BARRIENTOS, AS THE SECOND PARTY, FOR THE INSTALLATION OF STREETLIGHTING (POST LAMP) ALONG ILLINOIS ST., BARANGAY BAGONG SILANGAN, DISTRICT III, QUEZON CITY IN THE AMOUNT OF ONE HUNDRED SIXTY-FIVE THOUSAND TWO HUNDRED SIXTY THREE PESOS (P165,263.00)
