## RESOLUTION NO. SP-1360, 5-2000

A RESOLUTION AUTHORIZING THE HONORABLE ISMAEL A. MATHAY, JR., CITY MAYOR, TO ALLOCATE THE AMOUNT NECESSARY FOR THE INITIAL IMPLEMENTATION OF THE MASTER DEVELOPMENT PLAN AND WORK PROGRAM FOR THE CONSTRUCTION OF THE PROPOSED MATHAY PARK IN BARANGAY MILAGROSA IN PURSUANCE OF ORDINANCE NO. SP 7 6, S-98 OUT OF THE MAYOR'S COMMUNITY DEVELOPMENT FUND OR ANY OTHER AVAILABLE FUND IN THE CITY TREASURY.

WHEREAS, the City government, through Ordinance No. SP-756, S-98, has donated a five Thousand (5,000) square meter lot to Barangay Milagrosa for development as a park, playground and site of a multi-purpose hall, among other barangay requirements:

WHEREAS, a Master Development Plan and Work Program have been completed by the City Planning Office in pursuance of Ordinance No. SP-756, S-98;

WHEREAS, the residents of Barangay Milagrosa, numbering about Ten Thousand (10,000) inhabitants, have no playground of their own where the youth, senior citizens and other residents in general could spend their leisure time and engage in athletic and sports activities, and the barangay has no multi-purpose hall of its own for its varied barangay activities,

WHEREAS, a barangay resolution has proposed the name of Mathay Park as the name for the new park in loving memory of the late Ismael A. Mathay, Sr., a statesman and outstanding public servant in his time and father of the City Mayor;

## NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to authorize, as it does hereby authorize, the Honorable Ismael A. Mathay, Ir., City Mayor, to allocate the amount necessary for the initial implementation of the Master Development Plan and Work Program for the construction of the proposed Mathay Park in Barangay Milagrosa in pursuance of Ordinance No. SP-756, S 98 out of the Mayor's Community Development Fund (CDF) or any other available fund in the City Treasury.
