RESOLUTION NO. SP- 1364, S-2000

A RESOLUTION RATIFYING THE NEGOTIATED CONTRACT ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY JR., AND JWL BUILDERS, REPRESENTED BY MS. WILMA L. MARIANO, FOR THE COMPLETION OF THE CONSTRUCTION OF THE MULTI-PURPOSE HALL (PH.D) AT BARANGAY BUNGAD, QUEZON CITY IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED THOUSAND AND SIX HUNDRED EIGHTY PESOS (P1,700,680.00) (ANNEX "A").


WHEREAS, after proper negotiations on November 08, 1999, the Quezon City government represented by Mayor Ismael A. Mathay, Jr., entered into a Negotiated Contract with JWL Builders represented by its General Manager, Ms. Wilma L. Mariano, for the completion of the construction of the Multi-Purpose Hall (PH.D) at Barangay Bungad, Quezon City, in the amount of One Million Seven Hundred Thousand Six Hundred Eighty Pesos (1,700,680.00) copy of which is hereto attached as Annex "A" hereof;

WHEREAS, it appearing that the above Negotiated Contract is regular in every respect, thus, the same be ratified by the City Council;
