RESOLUTION NO. SP-1365 S-2000

A RESOLUTION AUTHORIZING HIS HONOR, MAYOR ISMAEL A. MATHAY, JR., TO ENTER INTO A CONTRACT OF LEASE WITH CAPITOL JAYCEES OF QUEZON CITY REPRESENTED BY ITS PRESIDENT.

WHEREAS, the Capitol Jaycees, Quezon City, has requested the Quezon City Council to adopt a resolution for the renewal of the Contract of Lease entered into by and between the Quezon City government and the former which expired on June 16, 1996;

WHEREAS, Section 22 (c) of Republic Act No. 7160, otherwise known as the "Local Government Code" provides, among other things, that:

"Unless, otherwise provided in this Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sangguniang concerned."

WHEREAS, under the same code, particularly Section 455 (b) (1) (vi), further provides that:

"The City Mayor, shall represent the City in all its business transactions and sign in its behalf all x x x, contracts x x x, and such other documents upon authority of the sangguniang panlungsod or pursuant to law."

WHEREAS, there is a need to authorize the City Mayor to enter into a contract with the Capitol Jaycees of Quezon City in order for the latter to continue to occupy the city government property at Bernardo Park, subject matter of the previous contract, under reasonable terms and conditions advantageous to the Quezon City government.


NOW, THEREFORE,
