RESOLUTION NO. SP 1372 S-2000

A RESOLUTION RATIFYING THE CONTRACT MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR. AS THE FIRST PARTY, AND ANGELOT CONSTRUCTION AND GENERAL MERCHANDISE, REPRESENTED BY ITS GENERAL MANAGER, MS. ANGELITA E. BARRIENTOS, AS THE SECOND PARTY, FOR THE IMPROVEMENT OF THE DRAINAGE SYSTEM ALONG MCBI COMPOUND, BARANGAY SAN AGUSTIN, NOVALICHES, QUEZON CITY IN THE AMOUNT OF NINETY THREE THOUSAND TWO HUNDRED TWELVE PESOS (P93,212.00).

WHEREAS, after the proper negotiations, the Quezon City government, represented by Mayor Ismael A. Mathay, Jr., executed a Contract with Angelot Construction and General Merchandise represented by its General Manager, Ms. Angelita E. Barrientos, as the Second Party, for the improvement of the drainage system along MCBI Compound, Barangay San Agustin, Novaliches, Quezon City in the amount of Ninety-Three Thousand Two Hundred Twelve Pesos (P93,212.00), as evidenced by a copy of said Contract hereto attached as Annex "1" to form an integral part hereof;

WHEREAS, the negotiated Contract (Annex "1") is valid and legal in all respect and may be ratified by the City Council;
