RESOLUTION NO. SP- 1373, S-2000

A RESOLUTION ALLOCATING FOUR HUNDRED FORTY-SIX THOUSAND PESOS (P446,000.00) OR SO MUCH THEREOF, TO PROVIDE IMMEDIATE RELIEF ASSISTANCE TO THE VICTIMS OF FIRE CONSISTING OF ONE HUNDRED SIXTY-SEVEN (167) HOUSE-OWNERS AND ONE HUNDRED TWELVE (112) HOUSE-RENTERS/SHARERS, AT BAYAN AND MOORE STREETS, BARANGAY BUNGAD, DISTRICT I, QUEZON CITY, THE NECESSARY FUNDS THEREFOR TO BE TAKEN FROM GRANTS, SUBSIDIES AND CONTRIBUTIONS OR FROM ANY OTHER AVAILABLE FUNDS IN THE CITY TREASURY.


WHEREAS, a fire occurred at Bayan and Moore Streets, Barangay Bungad, District I, Quezon City, at around 11:30 p.m. last November 13, 1999, affecting One Hundred Sixty-Seven (167) house-owners and One Hundred Twelve (112) house-renters/sharers;

WHEREAS, these unfortunate fire victims need the help and assistance of the City government in the form of material assistance, such as building materials for the reconstruction of their houses, purchase of food, clothing, etc., in the amount of Two Thousand Pesos (P2,000.00) for each house-owner and One Thousand Pesos (P1,000.00) for each house-renter/sharer;


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to allocate, as it does hereby allocate, Four Hundred Forty-Six Thousand Pesos (P446,000.00) or so much thereof, to provide immediate relief assistance to the victims of fire consisting of One Hundred Sixty-Seven (167) house-owners and One Hundred Twelve (112) house-renters/sharers, at Bayan and Moore Streets, Barangay Bungad, District I, Quezon City, the necessary funds therefor to be taken from Grants, Subsidies and Contributions or from any other available funds in the City Treasury.
