RESOLUTION NO. SP- 1378, S-2000

A RESOLUTION AUTHORIZING THE ISSUANCE OF A SPECIAL USE PERMIT TO STATION I ENTERPRISES FOR THE CONSTRUCTION OF A GASOLINE SERVICE STATION AT NO. 55 SAMPAGUITA STREET, MALIGAYA PARK SUBDIVISION, BARANGAY PASONG PUTIK PROPER, NOVALICHES, QUEZON CITY, NO. 23 BANLAT ROAD, TANDANG SORA, QUEZON CITY, AND AT NO. 92 J.P. RIZAL STREET, BARANGAY STA. LUCIA, NOVALICHES, QUEZON CITY.

WHEREAS, petitioner Station I Marketing has requested the Quezon City Council for the issuance of a Special Use Permit for the construction of a gasoline service station at No. 55 Sampaguita Street, Maligaya Park Subdivision, Barangay Pasong Putik Proper, Novaliches, Quezon City at No. 23 Banlat Road, Tandang Sora, Quezon City and at No. 92 J. P. Rizal Street, Barangay Sta. Lucia, Novaliches, Quezon City;

WHEREAS, the construction and establishment of the gasoline service station in the above-stated area is beneficial to the general public and that the proposed site conforms with the list of permitted uses which require the issuance of a Special Use Permit as provided under Ordinance No. SP-22, S-92, otherwise known as "The Quezon City Zoning Ordinance of 1992" and its implementing Rules and Regulations through an appropriate measure passed by the City Council authorizing the construction thereof;

WHEREAS, despite a 3-year negotiation with the owners of the property, the right of way problem could not be resolved.


NOW, THEREFORE,
