RESOLUTION NO. SP. -1389 , 3-2000

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR ISMAEL A. MATHAY, JR. TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) ON THE PROPOSED "STREET AND URBAN WORKING CHILDREN PROJECT" (SUCWP) UNDER PROJECT PHI 5478, MORE PARTICULARLY KNOWN AS "THE STREET CHILDREN NUTRITION AND EDUCATION PROGRAM" (SCNEP).

WHEREAS, the Government of Australia thru Australian Agency for International Development (AusAID) has approved Project 5478, more particularly known as "The Street Children Nutrition and Education Program (SCNEP) which is currently implemented in thirteen (13) local government units in the country including Quezon City;

WHEREAS, Vulnerable Groups Facility (VGF), as established by the government of Australia and being coordinated by a Technical Advisory Group (VGFTAC) composed of the National Economic Development Authority (NEDA), the Department of Budget and Management (DBM) and the Australian Agency for International Development (AusAID), aimed to increase the basic social services extend to vulnerable groups such as children and urban and rural poor;

WHEREAS, the Department of the Interior and Local Government (DILG) proposed the "Street and Urban Working Children Project" (SUWCP) which represents an expansion on the on-going SCNEP;

WHEREAS, under the VGFTAC-approved SUWCP, the project area sector coverage has been increased and expanded, respectively, with the addition of 12 local government units to the present thirteen (13) LGU's covered by the SCNEP and the inclusion of urban working children and their parents as beneficiaries;

WHEREAS, the DILG, by virtue of its mandate to enchance the capability of the LGUs in the delivery of basic services to their constituents, has been designated as the executing agency for the aforementioned project.
