RESOLUTION NO. SP- **1390** S72000

A RESOLUTION RATIFYING THE EIGHT (8) CONTRACTS MADE AND ENTERED INTO BY AND BETWEEN THE QUEZON CITY GOVERNMENT, REPRESENTED BY MAYOR ISMAEL A. MATHAY, JR., AS THE FIRST PARTY, AND BRYAN RANCES BUILDERS AND TRADING, REPRESENTED BY ITS PROPRIETRESS, MS. MARILOU H. RANCES, AS THE SECOND PARTY, FOR THE INSTALLATION OF EIGHT (8) ARTESIAN WELLS AT UNIT V AND E. CASTILLO ST., BARANGAY COMMONWEALTH; SAN DIEGO ELEMENTARY SCHOOL, BARANGAY BATASAN HILLS; AMOR STREET, BARANGAY GREATER LAGRO; KALIGAYAHAN ELEMENTARY SCHOOL, BARANGAY KALIGAYAHAN; 38 SAN JOSE STREET, BARANGAY SAN ANTONIO; RUBY STREET BARANGAY FAIRVIEW; AND FLORENCIA STREET, COR 23 W. RIVERSIDE, ALL IN QUEZON CITY IN THE AMOUNT OF FIFTY FOUR THOUSAND EIGHT HUNDRED SIXTY PESOS (P54,860.00) EACH.

WHEREAS, all the above-stated negotiated Contracts (Annex "F") are legal and valid in every respect and may be ratified by the City Council;


NOW, THEREFORE,

Rances, as the Second Party, for the installation of eight (8) artesian wells at Unit V and E, Castillo St., Barangay Commonwealth, San Diego Elementary School, Barangay Batasan Hills; Amor Street, Barangay Greater Lagro, Kaligayahan Elementary School, Barangay Kaligayahan; 38 San Jose Street, Barangay San Antonio; Ruby Street Barangay Fairview; and Florencia Street, cor. 23 W. Riverside, all in Quezon City in the amount of Fifty Four thousand Eight Hundred Sixty Pesos (P54,860.00) each.
