RESOLUTION NO. SP- 1391, S-2000

A RESOLUTION BESTOWING SPECIAL COMMENDATION TO MESSRS. ROMEO D.R. JUACHON, VICE CHAIRMAN FOR PROGRAMS, BOY SCOUT OF THE PHILIPPINES, QUEZON CITY CHAPTER AND M-38 DISTRICT DEPUTY, KNIGHTS OF COLUMBUS, MSGR. MIGUEL P. NUGUID COUNCIL 6632, AND JESUS P. CARREON, M-38 DISTRICT WARDEN, ALSO OF THE SAME COUNCIL, BOTH OF WHOM ARE RESIDENTS OF QUEZON CITY, FOR THEIR EXEMPLARY AND HEROIC FEAT IN THE RESCUE OF EIGHT SURVIVORS IN A VEHICULAR ACCIDENT ALONG THE NORTH LUZON EXPRESSWAY IN MEYCAUAYAN, BULACAN.

WHEREAS, the supreme act of saving the life of one person – the life that is other than your own, constitute not only a Christian act but exemplary, selfless and heroic feat as well that deserves the highest praises and accolades from people from all walks of life;


WHEREAS, two kindred souls, both residents of our beloved Quezon City, without regard for their own personal safety, dared to risk their own lives to save eight surviving passengers of an ill-fated Toyota Tamaraw FX Mega Taxi, one of whom was Ms. Helen Vinluan, who was a teacher at the San Francisco Elementary School, Del Monte, Quezon City, which crashed into the meter-high concrete culverts scattered along the grassy center island dividing the north and south bound lanes and rolled over once, thus, killing another passenger instantly;

WHEREAS, Messrs. Romeo D R Juachon and Jesus P. Carreon wasted no time at all and marshalled enough courage and strength, acting swiftly and instinctively thereby averting the further loss of other passersby and pulled out the bloodied and injured passengers who were later brought to the Sta. Clara de Montefalco Hospital in Meycauayan, Bulacan.


NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF QUEZON CITY IN SESSION ASSEMBLED, to bestow, as it does hereby bestow, special commendation to Messrs. Romeo D.R. Juachon, Vice Chairman for Programs, Boy Scout of the Philippines, Quezon City Chapter and M-38 District Deputy, Knights of Columbus, Msgr. Miguel P. Nuguid Council 6632, and Jesus P. Carreon, M-38 District Warden, also of the same Council, both of whom are residents of Quezon City, for their exemplary and heroic feat in the rescue of eight survivors in a vehicular accident along the North Luzon Expressway in Meycauayan, Bulacan.
